DELOITTE RIDE ACROSS BRITAIN 2021

1 REGISTRATION

- 1.1 The Deloitte Ride Across Britain (“Event”) is a multi-stage cycle event scheduled to take place between 4th-12th September 2021 and is organised by Threshold Sports Ltd (“Threshold”) and shall be referred to as the “Deloitte Ride Across Britain” or such other title as Threshold may advise.
- 1.2 Only persons aged 18 years or above as of 4th September 2021 may register for the Event.
- 1.3 Applicants must complete and submit the online registration form (“Online Registration Form”), which can be found at www.rideacrossbritain.com (the “Event Website”), and pay the entry fee (the “Entry Fee”) and the booking fee between £10.00 - £15.00 per place (the “Booking Fee”).
- 1.4 All successful applicants (hereinafter referred to as “Participants”) will be notified by way of an email confirmation that they have been allocated a place to take part in the Event (“Online Confirmation”).
- 1.5 Places in the Event are strictly limited and therefore applications are subject to availability. Subject to Clauses 1.2 to 1.4 (inclusive) above, Threshold will consider applications on a first come, first served basis by eligible Participants (which Threshold shall determine in its absolute discretion) and otherwise in accordance with these Rules and Regulations.
- 1.6 The relevant date for registrations shall be the date the Participant receives the Online Confirmation. Threshold is not responsible for technical, hardware or software failures of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer/Internet transmissions or other errors or malfunctions of any kind which may prevent receipt by Threshold of an Online Registration Form or receipt by an applicant of an Online Confirmation. For the avoidance of doubt, if, for any reason whatsoever, an applicant does not receive an Online Confirmation, said applicant shall not be considered to be a Participant and Threshold shall not be responsible for the applicant’s failed application.
- 1.7 All online registrations must be received by Threshold on or before midnight on Sunday 22nd August 2021 (“Entry Deadline”). Any online registration received by Threshold after the Entry Deadline will not be accepted. This deadline is subject to change if all entries are full prior to the above date.
- 1.8 Payments should be made directly to Threshold Sports, via the online payment system. Participants may elect to pay the Entry Fee and Booking Fee in full on registration, or pay a deposit (“the Deposit”) and then further payments (“Instalment Payments”) and the Booking Fee to confirm their place on the Event. These two different payment options are detailed in Section 2.

2 ENTRY FEES

2.3 Instalment Payments are not available for Charity Entry packages.

2.4 If a package is bought after an instalment date, the missed instalment(s) will be charged along with the deposit at the point of registration

2.5 Instalment Payments can be opted into at the point of check-out during registration.

2.5.1 If a package is bought after an instalment date, the missed Instalment Payment(s) will be charged along with the deposit at the point of registration

2.5.2 The Instalment Payments will be automatically taken from the original payment card on the dates listed in Clause 2.2. You must ensure that you have sufficient funds to cover this.

2.5.3 The Participant will receive an automated receipt by email after clearance of each payment.

2.5.4 If an Instalment Payment is missed, the Instalment Payment plan will be cancelled and the Participant will have only have the option to pay the remaining balance in full. This can be done by the Participant within the 'MyEvents Portal in the 'Billing Management' section.

2.5.5 If the Participant would like to pay the remaining balance early, or the payment card needs to be amended, this can be done by the Participant within the 'MyEvents Portal in the 'Billing Management' section.

2.5.6 If an Instalment Payment is missed and not paid within 15 working days, Threshold reserve the right to remove the Participant from the Event and their payments refunded in line with the Refund Policy in Clause 3.2

2.6 Subject to the other provisions of Section 1, submission of the Online Registration Form, payment of the Entry Fee, receipt of the Online Confirmation shall (together) entitle the Participant to participate in the Event.

2.7 Threshold reserve the right to change the dates that the Entry Fee increases.

- 2.8 The Event is personal to the Participant accepting these Rules and Regulations, and the Participant undertakes and agrees (i) only to participate in the Event wearing the number assigned to his/her registration, (ii) not to authorise or permit any third party to use his/her rider number for the Event and (iii) not to sell, transfer or give any other person the right to participate in the Event and/or use the Participant's number.
- 2.9 If at any time it is discovered that any Participant should have been ineligible to participate in the Event or if participation in the Event should have been refused for any reason whatsoever, Threshold reserves the right to disqualify such Participant from/refuse such Participant entry to the Event. Further, Threshold reserves the right to reject at any time any Online Registration Form which it believes to be fraudulent, or to disqualify at any time any Participant it believes not to have fully complied with these Rules and Regulations from participating in the Event, or in any future Threshold events. Threshold shall not be liable in any way to such Participant as a result of any such disqualification or refusal. It is the Participant's responsibility to ensure full compliance with these Rules and Regulations.
- 2.10 If any provision in these Rules and Regulations, whether in full or in part, is held to be invalid or unenforceable, all other remaining provisions (in full or in part) shall continue to be valid and enforceable.
- 2.11 These Rules and Regulations (and any documents referred to herein) constitute the entire agreement and understanding of the parties and supersede any previous agreement between the parties relating to the Event. Nothing in these conditions shall constitute or be deemed to constitute a partnership between the parties. These Rules and Regulations shall be interpreted in accordance with the laws of England and Wales and any dispute arising hereunder shall be subject to the exclusive jurisdiction of the English courts.

3 CANCELLATIONS & REFUNDS POLICY

- 3.1 Any Participant intending to cancel their place in the Event shall inform Threshold as soon as reasonably practicable ("Cancellation Notification").
 - 3.1.1 Threshold operates a seven (7) day cooling off period. Accordingly, the Participant is entitled to cancel his/her Entry to participate provided Threshold receives written notice of cancellation within seven (7) days of payment of registration. During this 7 day period the Participant is able to cancel his/her entry and receive a full refund of all fees paid to date (including the Deposit) by emailing info@rideacrossbritain.com. The notice must be received before the end of the seven (7) day cooling off period. The Booking Fee is non-refundable.
 - 3.1.2 Thereafter, an amount will be refunded to the Participant as outlined in Clause 3.2, within 30 days of receipt by Threshold of the Cancellation Notification from the Participant.
 - 3.1.3 The amount refunded to the Participant is dependent on the date in which the Cancellation is requested and the payment plan the Participant has chosen. These amounts are shown in Clause 3.2.
 - 3.1.4 Additional extras purchased that are managed by Threshold Sports such as merchandise and laundry will be refunded in full
 - 3.1.5 Additional extras purchased that are managed by 3rd parties such as participant transport, bike transport and registration insurance are subject to the individual parties' terms and conditions
 - 3.1.6 If the Participant is a charity entry, any donations raised will not be refunded
- 3.2 Refund Policy after seven (7) day cooling off period.

3.3 PARTICIPANT TRANSFER

3.3.1 A Participant can transfer their entry to another individual if notice is given to Threshold. Participants who transfer their Entry can be eligible for a full refund of all Fees paid (minus the Booking Fee and the Administration Fee) subject to Clauses 3.3.1 - 3.3.7.

3.3.2 Notice of a Participant Transfer must be done via the Participant's [MyEvents](#) Portal.

- Click Transfer registration to another athlete
- Enter recipient email address in email address field
- Enter recipient email address in Confirm email address field and click Submit
- Confirmation email sent verifying transfer process initiated to transferring Participant and to a new Participant

3.3.3 If the Participant wishes to do a Participant Transfer, any Instalment Payments outstanding must be cleared immediately before the Participant Transfer can be processed

- 3.3.4 Participant Transfers can only take place if the current participant new Participant wishes to take the same Event Package
- 3.3.5 The most current Entry Fee and Booking Fee is applied at checkout when the new Participant accepts the transfer by clicking the link within the confirmation email detailed in 3.3.2 This Entry Fee could be higher than that for the original Participant
- 3.3.6 The original Entry Fee is not refunded until the new Participant accepts and completes the transfer process.
- 3.3.7 Additional extras purchased will be refunded in line with 3.1.4-3.1.5
- 3.3.8 Refunds are processed within 5-7 business days.
- 3.3.9 The Administration Fee will be deducted automatically from the refund as follows:
- Before 23:59, 25th July 2021: £75
 - Before 23:59, 22nd August 2021: £85
- 3.3.10 Participants who are deferring their place from 2020 and would like to do a Participant Transfer can do so up until 23:59, 31st December 2020 free of charge. After this time the Administration Fees will apply outlined in 3.3.9. Please note that those transferring to a higher priced package are required to pay the increase in fee and those transferring to a lower priced package will not receive a refund for the difference in price. Participants must email info@rideacrossbritain.com to process this.

3.4 PARTICIPANT CHANGE OF PACKAGE

- 3.4.1 A Participant can change their package if notice is given to Threshold.
- 3.4.1.1 Notice of the change must be communicated by the Participant by emailing info@rideacrossbritain.com stating clearly the desire to change their entry. The Participant may be required to pay an additional Entry Fee before the package change can be confirmed, which is payable over the phone by calling 0207 605 6720.
- 3.4.2 No changes to a Participants Package can be accepted after 23:59 22nd August 2021
- 3.4.3 If the Participant wishes to do a change of Package, any Instalment Payments outstanding must be cleared immediately before the Participant Change of Package can be processed
- 3.4.4 If the Participant is changing to a package with a lower Entry Fee, they will be refunded the difference to the card with which the Participant paid their initial Entry Fee. The refund will not exceed that the Refund Policy outlined in Clause 3.2.
- 3.4.5 If the Participant is changing to a package with a higher Entry Fee, the difference plus any incremental Booking Fees for making the change must be paid before the Participant can complete the change.
- 3.4.6 Once the Fee has been processed, Threshold will send the Participant a new confirmation email, which will act as the new Online Confirmation.

3.5 PARTICIPANT DEFERRAL

- 3.5.1 A Participant is permitted to defer their entry to the following year (2022 event), subject to the following circumstances:
- 3.5.1.1 Notice of the deferral must be communicated by the Participant by emailing

info@rideacrossbritain.com stating clearly the desire to defer their entry. The Participant is required to pay the Administration Fee before the package change can be confirmed, which is payable over the phone by calling 0207 605 6720.

- 3.5.2 If the Participant wishes to defer, any Instalment Payments outstanding must be cleared immediately before the Entry Deferral can be processed
- 3.5.3 The Instalment Payments and the Administration Fees are both payable over the phone by calling 0207 605 6720.
- 3.5.4 The deadline for deferrals and Administration Fees are as follows. No requests for deferrals will be accepted after the below deadlines:

- 3.5.5 Once the correct Entry Fees have been paid and Administration Fee has been processed, Threshold will cancel the Participant registration for 2021. Threshold will not refund the Entry Fee but will then send the Participant a free of charge web link to sign up to the event the following year.
- 3.5.6 Additional extras purchased will be refunded in line with 3.1.4-3.1.5
- 3.5.7 If the Participant wishes to change their package, it is then the responsibility of the Participant to complete following the steps outlined in Clause 3.4 once they have completed their registration for 2022
- 3.5.8 Threshold reserves the right to discontinue the RAB Plus package. Therefore, if a RAB Plus Participant defers their entry to 2022 they may only be able to obtain a Classic package place.
- 3.5.9 The Participant understands that once a deferral has been processed, the Administration Fee is non-refundable under any circumstances. The retained Entry Fee will then be subject to the Refund Policy for 2022
- 3.5.10 A participant can only defer their entry once. A deferral will not be permitted if the Participant has already deferred previously.
- 3.5.11 If a participant needs to defer due to Covid related reasons, such as being subject to a local lockdown, international quarantine, a positive test or self-isolation requirement, we will waive the Deferral Administration Fee. The participant must notify Threshold via email by the time that registration commences on the live event and provide evidence of the situation.

4 DELOITTE RIDE ACROSS BRITAIN

- 4.1 Subject to Clause 4.4 below, the Event will be held between 4th-12th September 2021.
- 4.2 The Event is made up of various options (“Packages”):
 - 4.2.1 “Classic package”- A nine day package from Land’s End to John O’Groats between 4th-12th September 2021
 - 4.2.2 “Plus package” – A nine day package from Land’s End to John O’Groats between 4th-12th

- September 2021
- 4.2.3 “England package” - A six day package from Land’s End to Edinburgh scheduled to take place between 4th- 10th September 2021
- 4.2.4 “Scotland package” - A three day package from Edinburgh to John O’Groats scheduled to take place between 10th -12th September 2021
- 4.3 The Event is an arduous multi-day endurance cycling event, involving the completion of a fully signed route. Participants are encouraged to cycle in groups (with chaperone guidance) for reasons of safety, although this is not compulsory.
- 4.4 Threshold reserves the right to change the time, date, route and/or format of the Event, or, in exceptional circumstances, to cancel the Event, in whole or in part, without liability to the Participant. In such cases, Threshold:
- 4.4.1 will make a reasonable effort to provide notice of the changes/cancellation via email. If email notice is not practicable due to the timescales involved, we will use reasonable alternative methods of notice including text messages;
- 4.4.2 will have no responsibility or liability for any costs incurred, including any travel or accommodation costs whether existing or additional, as a result of the changes/cancellation; and
- 4.4.3 undertakes to act with full transparency and fully observe and satisfy its legal obligations to you at all times.
- 4.5 If, due to Covid-19, Threshold change the time, date, route and/or format of the Event, or, in exceptional circumstances, cancel the Event, in whole or in part, the Participant will have the option to receive a full refund of their Entry Fee paid to date, less the Booking Fee.
- 4.6 Threshold reserves the right to remove any Participant from the Event, either during or before it, due to ill health, or any other reason (at Threshold’s discretion) that may render him/her unfit to safely complete the Event. The Participant confirms that they will not take part in the Event if the Participant is suffering from any contagious illness (to include, but not exclusively, symptoms suggestive of Covid-19 infection and diarrhoea or vomiting symptoms) and confirms that he/she will report any illness during the Event, to the Event medical team immediately.
- 4.7 The Participant agrees to complete a Health Screening questionnaire and/or body temperature screen where this is deemed necessary by the Event Organiser or the Event Medical Team.
- 4.8 The Participant agrees to follow all instructions and guidelines issued by the Event Organiser, observe all protocols and adhere to any measures that may be in place at the Event in order to address and help mitigate the risk presented by Covid-19. Such safeguards may include the Participant having to complete a Health Screening questionnaire and/or body temperature screening where this is deemed necessary by the Event Organiser or the Event Medical Team.
- 4.9 Irrespective of any safeguards that may be put in place by the Event Organiser, Participation in the Event is at the Participant’s own risk, including risk to the Participant themselves (in particular with respect to the transmission of Covid-19 or any variant) and any damage caused by/to third parties or third party property. The Participant irrevocably agrees to hold harmless, indemnify and reimburse Threshold from and for any sum, costs or expenses (including legal and professional fees) incurred, payable or paid by Threshold to any person (including the Participant and/or any of the Participant’s insurers) in connection with any accident, loss, damage or injury (including death) arising out of the Participant’s attendance at and participation in the Event or any part thereof (except where any such injury or death is caused by the negligence of Threshold or any of its employees).
- 4.10 If the Participant becomes ill with Covid-19 related symptoms within 3 weeks of the Event, they agree to inform Threshold so that they can assist with necessary ‘tracking and tracing’ in line with government policy at the time
- 4.11 The Participant agrees to be contacted by Threshold after the event should another participant on the Event develop symptoms of Covid-19 within 3 weeks of the Event

- 4.12 Without prejudice to Threshold's right to remove any Participant from the Event due to ill health pursuant to Clause 4.5 above, the Participant acknowledges and agrees that:
- 4.12.1 If the Participant becomes ill with a non-infectious illness (as determined by the Event medical team) during a stage but wishes to join a subsequent stage, Threshold will, where reasonably practicable and subject to the advice of the Event medical team, transfer him/her to the next base camp. Where such transfer is not reasonably practicable (or where the Event medical team advise against the Participant's continued involvement in the Event), the Participant shall be removed from the Event.
- 4.12.2 If, however, the Participant becomes ill with an infectious illness (as determined by the Event medical team), the Participant shall be removed from the Event.
- 4.13 The accommodation provided with the Classic package, England package and Scotland package is camping in the identified Event base camps apart from Bath where accommodation will be in a university single occupancy room. The Plus package includes hotel accommodation (either single or double occupancy in a double bedded room) each night on the event, with the exception of Bath when the accommodation will be in University single occupancy rooms and Saturday 11th September, which will be camping, in line with the other packages. Please note that the double occupancy option does not necessarily include twin bedded rooms.
- 4.14 In the event of a Participant having to leave the Event because of injury, illness or voluntary withdrawal, the Participant will be responsible for all repatriation travel costs and organization of onward travel.
- 4.15 Threshold will endeavor to provide every Participant with a completion time but is not responsible for any electronic timing anomalies.
- 4.16 No drugs, illegal substances, performance enhancing substances or intoxicants of any kind are permitted to be used by any Participant either before or during participation in the Event. Threshold reserves the right to refuse attendance at, or participation in, the Event by any persons found to have consumed or to have in their possession any drugs, illegal substances, performance enhancing substances or intoxicants of any kind.
- 4.17 Threshold reserves the exclusive right and license throughout the world (and Participant hereby grants Threshold such exclusive right and licence) to interview and/or photograph and/or film the Participant at the Event (and before and after the Event as Threshold may reasonably require) and to the unlimited, worldwide, sub-licensable right to record, film, reproduce and use in all current and future media (including without limitation, print, audio, visual, audio-visual, virtual media, the Internet, mobile telephony and so-called "3-G" technologies, CD-ROM or DVDs) the Participant's name, likeness and image or facsimile image, signature, voice, video and film portrayals and other means of identification of the Participant, and any biographical or other information or data related to the Participant (including ride times and results), in connection with the production, advertisement, marketing, promotion or sale of Event sponsor products and/or the promotion, marketing or advertisement of Threshold or any Event sponsor or partner.
- 4.18 As a continuing condition of entry each Participant shall ensure that, for the duration of the Event:
- 4.18.1 Safety approved cycle helmets are worn at all times when cycling;
- 4.18.2 The Participant is capable of carrying out basic bike maintenance, such as puncture repairs, whilst on the route;
- 4.18.3 The Participant does not start earlier than the official start time on each day of the Event. Failure to comply with this rule will result in being removed from the event;
- 4.18.4 The Participant completes each daily stage between the hours of the route operating window ("Route Operating Window") which is normally 7am to 7pm. In addition, the Participant must start each stage within the start window of one hour ("Start Window"), normally 7am to 8am. Threshold reserves the right to alter the Route Operating Window and the Start Window each day in the event of mitigating circumstances;

- 4.18.5 The Participant cycles at a minimum average pace of 10mph, or above, each day. Pit stop cut off times will be advertised each day for this pace of rider. If a Participant falls behind this pace then the Participant will be collected by the broom wagon and repatriated to the next base camp.
- 4.18.6 The Participant understands that pit stop cut off times are guides only. Threshold reserves the right to ask any rider to go on the broom wagon at any time, if they feel they are a risk to themselves, other riders, or are unnecessarily stretching the route support crew, even if they are still within the pit stop cut off times and/ or Route Operating Window.
- 4.18.7 The Participant understands the three-strike rule and will be asked to leave the Ride after the third strike and not permitted to take part in the remainder of the Event. The Participant would get ONE strike if the Participant:
- 4.18.7.1 is collected during the day because they fail to make the pit stop cut off times;
 - 4.18.7.2 does not start on a particular day, and travels in the broom wagon to the next basecamp;
 - 4.18.7.3 does not start on a particular day, and organises their own transfer to the next basecamp but needs their bike to be transported by the broom wagon;
 - 4.18.7.4 does not start on a particular day and organises their own transfer to the next basecamp for themselves AND their bike. Riders must still tell Event Control if doing this;
 - 4.18.7.5 has left pit stop 2 within the cut off time but does not reach the finish before that cut off time;
- 4.18.8 The Participant understands that Threshold shall have no liability whatsoever to any Participant who fails to complete the ride at an average pace of 10mph, but refuses to be collected by the broom wagon, and reserve the right to remove such Participant from the remainder of the Event;
- 4.18.9 The Participant understands that if they are removed from the Event for whichever circumstances outlined in these rules and regulations, no refund will be given by Threshold or any other party.
- 4.18.10 His/her bicycle is roadworthy for the Event and equipped with the relevant insurances and documentation;
- 4.18.11 The Participant does not use a mobile phone whilst cycling but has one on their person in case of emergencies;
- 4.18.12 Due to the outdoor nature and endurance aspect of the Event, the Participant maintains personal hygiene at all times, and adheres to all hygiene advice provided by Threshold;
- 4.18.13 The Participant does not use a music player with headphones whilst cycling;
- 4.18.14 The Participant displays the official event numbers provided at registration in the manner indicated during the Event;
- 4.18.15 The Participant does not deviate from the official signed route of the Event;
- 4.18.16 The Participant abides by all Event rules and regulations;
- 4.18.17 The Participant acknowledges that it is his/her responsibility to ensure that the Participant has taken out a policy of insurance suitable for his/her participation in the Event.
- Example of suitable insurance cover is outlined below, but not limited to:
- A minimum of £2 million 3rd Party Liability Insurance;
 - Travel insurance that covers personal travel plans; and
 - Insurance that covers personal belongings, including his/her bike
- 4.18.18 The Participant complies with the Highway Code at all times; and

- 4.18.19 The Participant obeys traffic officers and authorised marshals at all times; failure to do so will result in disqualification and removal from the Event.
- 4.18.20 A Participant is permitted to take part in the Event on an Electrically Assisted Pedal Cycle (e-bike) as a reasonable adjustment for a registered disability whereby the e-bike will enable them to complete the Event.
 - 4.18.20.1 the Participant must email info@rideacrossbritain.com to inform Threshold of the use of an e-bike so sufficient resource can be put in place
 - 4.18.20.2 the Participant must comply with the government rules in England, Scotland and Wales as to the classification of an e-bike and licensing, tax and insurance requirements, as set out here <https://www.gov.uk/electric-bike-rules>.
 - 4.18.20.3 the Participant must make sure the bike battery can last for the duration of the day as there will not be any charging facilities at pit-stops

5 PARTICIPANT WARRANTIES AND UNDERTAKINGS

- 5.1 The Participant acknowledges that participation in the Event is not possible without validly entering into this agreement on these Rules and Regulations and agrees to be bound by these Rules and Regulations.
- 5.2 The Participant agrees at all times during the Event to abide by the reasonable instructions and guidelines of Threshold's staff, nominated representatives, and suppliers and to behave appropriately at all times on the route and in the base camps. Participants acknowledge and agree that Threshold will organise and run the Event and will have sole authority and be the final arbiter on all decisions relating to the following aspects of the Event: health and safety, logistical operations, participation, organisation and rules and regulations.
- 5.3 The Participant understands the endurance demands of the Event and commits to preparing to take part in the Event by:
 - 5.3.1 Complying with the Event monthly training plans (or comparable training advice);
 - 5.3.2 Consistently completing long distance rides (min. 80 miles) before the Event;
 - 5.3.3 Completing a number of training rides on consecutive days in order to experience fatigue brought on by persistent mileage; and
 - 5.3.4 Undertaking regular training within a group in busy road conditions (e.g. roundabouts, major junctions) in order to feel confident out on the road.
- 5.4 The Participant acknowledges that participation in the Event involves inherent risks of accidents and injury.
- 5.5 The Participant acknowledges that the Participant is personally responsible for his/her own belongings during the Event, and that the Participant must collect any personal lost items from lost property before the Participant leaves the Event.
- 5.6 Participation in the Event is at the Participant's own risk. The Participant irrevocably agrees to hold harmless, indemnify and reimburse Threshold from and for any sum, costs or expenses (including legal and professional fees) incurred, payable or paid by Threshold to any person (including the Participant and/or any of the Participant's insurers) in connection with any accident, loss, damage or injury (including death) arising out of the Participant's attendance at and participation in the Event or any part thereof (except where any such injury or death is caused by the negligence of Threshold or any of its employees).
- 5.7 The Participant confirms without reservation that the Participant is in a good physical condition to participate in the Event, that the Participant understands the endurance demands of the Event, and will not arrive at the Event in ill health or unfit to take part.
- 5.8 The Participant confirms that the Participant has suitable liability, personal accident and equipment insurance in place in order to participate in the Event and acknowledges that the Participant has no claim against

Threshold in relation to the provision of such insurance.

- 5.9 The Participant confirms that the Participant will not publish or post on any website or other media operated by Threshold or related to the Event any text, statement, photograph, image or other material which is obscene, blasphemous, defamatory, infringes the intellectual property or other legal rights of any third party or is otherwise unlawful, offensive or inappropriate. Threshold will have the right to remove any material at its discretion and take appropriate legal action against any person found to be or alleged to be in breach of this Clause 5.9.
- 5.10 The Participant's journeys to and from the start and finish lines of the Event shall be entirely at his/her own risk and cost.

6 CHARITY PLACES & FUNDRAISING DECLARATION

- 6.1 If taking part as a charity place, you are required to fundraise the minimum outlined in the table below, or the figure agreed by your charity.

- 6.2 You are required to reach at least 25% of your target at least 12 weeks prior to the event. Failure to do this can result in your removal from the event.
- 6.3 You are required to reach at least 50% of your target at least 6 weeks prior to the event. Failure to do this can result in your removal from the event.
- 6.4 You are required to reach your full fundraising target no later than 4 weeks after the event.
- 6.5 If you wish to transfer from a charity place to a public place, you must pay the increase in Entry Fee.
