### DELOITTE RIDE ACROSS BRITAIN 2019 – CLASSIC, PLUS, ENGLAND & SCOTLAND

#### 1 REGISTRATION

- 1.1 The Deloitte Ride Across Britain (“Event”) is a multi-stage cycle event scheduled to take place between 7-15 September 2019 and is organised by Threshold Sports Ltd (“Threshold”) and shall be referred to as the “Deloitte Ride Across Britain” or such other title as Threshold may advise.
- 1.2 Only persons aged 18 years or above as of 7 September 2019 may register for the Event.
- 1.3 Applicants must complete and submit the online registration form (“Online Registration Form”), which can be found at [www.rideacrossbritain.com](http://www.rideacrossbritain.com) (the “Event Website”), and pay the registration fee (the “Registration Fee”) and the booking fee (the “Booking Fee”).
- 1.4 All successful applicants (hereinafter referred to as “Participants”) will be notified by way of an email confirmation that they have been allocated a place to take part in the Event (“Online Confirmation”).
- 1.5 Places in the Event are strictly limited and therefore applications are subject to availability. Subject to Clauses 1.2 to 1.4 (inclusive) above, Threshold will consider applications on a first come, first served basis by eligible Participants (which Threshold shall determine in its absolute discretion) and otherwise in accordance with these Rules and Regulations.
- 1.6 The relevant date for registrations shall be the date the Participant receives the Online Confirmation. Threshold is not responsible for technical, hardware or software failures of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer/Internet transmissions or other errors or malfunctions of any kind which may prevent receipt by Threshold of an Online Registration Form or receipt by an applicant of an Online Confirmation. For the avoidance of doubt, if, for any reason whatsoever, an applicant does not receive an Online Confirmation, said applicant shall not be considered to be a Participant and Threshold shall not be responsible for the applicant’s failed application.
- 1.7 All self-funded online registrations must be received by Threshold on or before midnight on Sunday 1st September 2019 (“Entry Deadline”). Any online registration received by Threshold after the Entry Deadline will not be accepted. This deadline is subject to change if all entries are full prior to the above date.
- 1.8 All part-funded Charity online registrations must be received by Threshold on or before midnight on Sunday 28<sup>th</sup> July September 2019 (“Charity Entry Deadline”). Any online registration received by Threshold after the Charity Entry Deadline will not be accepted. This deadline is subject to change if all entries are full prior to the above date.
- 1.9 The Registration Fee and further payments (“Instalment Payments”) that complete the full Registration Fee for the Event are due on the dates outlined in Section 2.

- 2.1 Participants will be notified via email the week before the instalment due date, with a link to pay the next balance ("Instalment Payment").
- 2.2 Payments should be made directly to Threshold Sports, via the online payment system. Participants may elect to pay for the entire package on registration, or commit to paying the full price in instalments (as above).
- 2.3 The Participant will receive an automated confirmation by email after clearance of each payment.
- 2.4 Subject to the other provisions of Clause 1, submission of the Online Registration Form, payment of the Registration Fee, receipt of the Online Confirmation and payment of the Instalment Payments shall (together) entitle the Participant to participate in the Event.
- 2.5 The Event is personal to the Participant accepting these Rules and Regulations, and the Participant undertakes and agrees (i) only to participate in the Event wearing the number assigned to his/her registration, (ii) not to authorise or permit any third party to use his/her rider number for the Event and (iii) not to sell, transfer or give any other person the right to participate in the Event and/or use the Participant's number.
- 2.6 If at any time it is discovered that any Participant should have been ineligible to participate in the Event or if participation in the Event should have been refused for any reason whatsoever, Threshold reserves the right to disqualify such Participant from/refuse such Participant entry to the Event. Further, Threshold reserves the right to reject at any time any Online Registration Form which it believes to be fraudulent, or to disqualify at any time any Participant it believes not to have fully complied with these Rules and Regulations from

participating in the Event, or in any future Threshold events. Threshold shall not be liable in any way to such Participant as a result of any such disqualification or refusal. It is the Participant's responsibility to ensure full compliance with these Rules and Regulations.

- 2.7 If any provision in these Rules and Regulations, whether in full or in part, is held to be invalid or unenforceable, all other remaining provisions (in full or in part) shall continue to be valid and enforceable.
- 2.8 These Rules and Regulations (and any documents referred to herein) constitute the entire agreement and understanding of the parties and supersede any previous agreement between the parties relating to the Event. Nothing in these conditions shall constitute or be deemed to constitute a partnership between the parties. These Rules and Regulations shall be interpreted in accordance with the laws of England and Wales and any dispute arising hereunder shall be subject to the exclusive jurisdiction of the English courts.

## 3 CANCELLATION OPTIONS

- 3.1 Any Participant intending to cancel their place in the Event shall inform Threshold as soon as reasonably practicable ("Cancellation Notification").

3.1.1 Threshold operates a seven (7) day cooling off period. Accordingly, the Participant is entitled to cancel his/her Entry to participate provided Threshold receives written notice of cancellation within seven (7) days of payment of the Registration Fee. During this 7 day period the Participant is able to cancel his/her entry and receive a full refund of the Registration Fee by emailing [info@rideacrossbritain.com](mailto:info@rideacrossbritain.com). The notice must be received before the end of the seven (7) day cooling off period.

3.1.2 Thereafter, an amount will be refunded to the Participant equal to the sum of their Registration Fee and Instalment Payments, minus the "Non-refundable Fee" (as outlined in Clause 3.2) within 30 days of receipt by Threshold of the Cancellation Notification from the Participant.

3.3 A Participant can transfer their entry to another individual (“Participant Transfer”) if notice is given to the Event Organisers.

3.3.1 Notice of a Participant Transfer must be communicated by the outgoing participant (“Outgoing Participant”) by emailing [info@rideacrossbritain.com](mailto:info@rideacrossbritain.com) stating clearly the desire to make a Participant Transfer and the full name and email address of the new entrant (“Incoming Participant”).

3.3.2 The outgoing participant remains responsible for any balance payments of the Registration Fee until these payments are made in full. The Outgoing Participant will need to make payment of the administration fee via phone by calling 0845 486 2012.

3.3.3 The deadlines and associated administration fee for this are:  
3.3.3.1 Before 12pm, 26th July 2019: £75

3.3.4 Once the administration fee has been processed, the Event Organisers will send the Incoming Participant a free of charge web link to sign up to the event and the Event Organisers will cancel the Outgoing Participant registration. Payment of the Registration Fee will need to be organised in a private transaction between the two participants.

3.4 A Participant can transfer packages if notice is given to the Event Organisers.

- 3.4.1 Notice of the transfer must be communicated by the Participant by emailing [info@rideacrossbritain.com](mailto:info@rideacrossbritain.com) stating clearly the desire to defer to transfer their entry. The Participant must pay the fee before the event transfer can be confirmed, which is payable over the phone by calling 0845 486 2012.
- 3.4.2 The deadlines and associated fees for this are:
- 3.4.2.1 12pm, 26<sup>th</sup> July 2019
- 3.4.3 If the Participant is transferring to a package with a decrease in Registration Fee, they will be refunded the difference between the Registration Fees to the card with which he/she paid their Registration Fee. If, however, the refund amount exceeds that of the “Non-refundable fee” for the original package, the amount refunded will be in line with the relevant “Non-refundable fee” according to the cancellation policy outlined in Clause 3.2.
- 3.4.4 If the Participant is transferring to a package with an increase in Registration Fee, this increase must be paid before the Participant can be transferred.
- 3.4.5 The new fee will be charged at as per the original date of entry of the Participant.
- 3.4.6 Once the fee has been processed, the Event Organisers will send the Participant a new confirmation email, which will act as the new Online Confirmation.
- 3.5 A Participant is permitted to defer their entry to the following year (2020 event) (“Entry Deferral”), subject to the following circumstances:
- 3.5.1 He/she must have either paid the relevant instalments or the full Registration Fee, depending on the day of deferral in line with the table in Clause 2.
- 3.5.2 He/she must pay the Deferral fee as outlined below in Clause 3.5.8
- 3.5.3 If he/she defers:
- 3.5.3.1 Before the First Instalment is due on 5th November 2018 or before the Final Instalment is due on 5th April 2019, he/she will need to pay the outstanding instalment(s) in line with the instalment deadline(s) for the following year (2020).
- 3.5.3.2 After the Final Instalment is due on 5th April 2019 and has any Instalment Payments outstanding to make up their Registration Fee, these must be cleared immediately before the Entry Deferral is processed. The Registration Fee for each package is outlined below;
- 3.5.4 The deadline for deferrals for Deloitte RAB Plus participants to defer:
- 3.5.4.1 To the Deloitte RAB Plus package in 2020: 31st May 2019.
- 3.5.4.2 To the Classic package in 2020: 7th September 2019. It is then the responsibility of the participant to contact Threshold Sports to arrange an upgrade to the Plus package in 2020 and this increase in cost must be paid at the time of upgrade.
- 3.5.5 Threshold reserves the right to discontinue the RAB Plus package. Therefore if a RAB plus defers their entry to 2020 this may be to the Classic package.
- 3.5.6 The deadline for deferrals for Deloitte RAB Public places (excluding Plus package) is 7<sup>th</sup> September 2019.

3.5.7 The deadline for deferrals for Deloitte RAB Charity places is 31<sup>st</sup> July 2019. For Deloitte RAB Charity Plus places, refer to Clause 3.5.3.1

3.5.7.1 When deferring, the participant should be able to carry over any donations to the new event, but it is the chosen charity's decision, so the participant should speak with the charity directly on this.

3.5.9 Once the correct Registration Fees have been paid and Deferral Fee has been processed, the Event Organisers will cancel the Participant registration for 2019. The Event Organisers will not refund the Registration Fee, but will then send the Participant a free of charge web link to sign up to the event the following year.

3.5.10 He/she understands that once an Entry Deferral has been processed, all monies are non-refundable under any circumstances.

3.5.11 A participant can only defer their entry once; a deferral will not be permitted if the Participant has already deferred previously.

## 4 DELOITTE RIDE ACROSS BRITAIN

4.1 Subject to Clause 4.4 below, the Event will be held between 7-15 September 2019.

4.2 The Event is made up of various options ("Packages"):

4.2.1 "Classic package"- A nine day package from Land's End to John O'Groats between 7-15 September 2019

4.2.2 "Plus package" – A nine day package from Land's End to John O'Groats between 7-15 September

- 4.2.3 “England package” - A six day package from Land’s End to Edinburgh scheduled to take place between 7-12 September 2019
- 4.2.4 “Scotland package” - A three day package from Edinburgh to John O’Groats scheduled to take place between 13-15 September 2019
- 4.3 The Event is an arduous multi-day endurance cycling event, involving the completion of a fully signed route. Participants are encouraged to cycle in groups (with chaperone guidance) for reasons of safety, although this is not compulsory.
- 4.4 Threshold reserves the right to change the time, date, route and/or format of the Event and to cancel the Event, in whole or in part, without notice or liability to the Participant. Threshold shall inform the Participant by email of any such change or cancellation.
- 4.5 Threshold reserves the right to remove any Participant from the Event, either during or before it, due to ill health, or any other reason (at Threshold’s discretion) that may render him/her unfit to safely complete the Event. The Participant confirms that he/she will not take part in the Event if he/she is suffering from any contagious illness (in particular diarrhea or vomiting symptoms) and confirms that he/she will report any illness during the Event, to the Event medical team immediately.
- 4.6 Without prejudice to Threshold’s right to remove any Participant from the Event due to ill health pursuant to Clause 4.5 above, the Participant acknowledges and agrees that:
  - 4.6.1 If he/she becomes ill with a non-infectious illness (as determined by the Event medical team) during a stage but wishes to join a subsequent stage, Threshold will, where reasonably practicable and subject to the advice of the Event medical team, transfer him/her to the next base camp. Where such transfer is not reasonably practicable (or where the Event medical team advise against the Participant’s continued involvement in the Event), the Participant shall be removed from the Event.
  - 4.6.2 If, however, he/she becomes ill with an infectious illness (as determined by the Event medical team), the Participant shall be removed from the Event.
- 4.7 The accommodation provided with the Classic package, England package and Scotland package is camping in the identified Event base camps apart from Bath where accommodation will be in a university single occupancy room. The Plus package includes hotel accommodation (either single or double occupancy in a double bedded room) each night on the event, with the exception of Bath when the accommodation will be in University single occupancy rooms and Saturday 15<sup>th</sup> September, which will be camping, in line with the other packages. Please note that the double occupancy option does not necessarily include twin bedded rooms.
- 4.8 In the event of a Participant having to leave the Event because of injury, illness or voluntary withdrawal, he/she will be responsible for all repatriation travel costs and organization of onward travel.
- 4.9 Threshold will endeavour to provide every Participant with a completion time but is not responsible for any electronic timing anomalies.
- 4.10 No drugs, illegal substances, performance enhancing substances or intoxicants of any kind are permitted to be used by any Participant either before or during participation in the Event. Threshold reserves the right to refuse attendance at, or participation in, the Event by any persons found to have consumed or to have in their possession any drugs, illegal substances, performance enhancing substances or intoxicants of any kind.
- 4.11 Threshold reserves the exclusive right and license throughout the world (and Participant hereby grants Threshold such exclusive right and licence) to interview and/or photograph and/or film the Participant at the Event (and before and after the Event as Threshold may reasonably require) and to the unlimited, worldwide, sub-licensable right to record, film, reproduce and use in all current and future media (including without limitation, print, audio, visual, audio-visual, virtual media, the Internet, mobile telephony and so-called “3-G”

technologies, CD-ROM or DVDs) the Participant's name, likeness and image or facsimile image, signature, voice, video and film portrayals and other means of identification of the Participant, and any biographical or other information or data related to the Participant (including ride times and results), in connection with the production, advertisement, marketing, promotion or sale of Event sponsor products and/or the promotion, marketing or advertisement of Threshold or any Event sponsor or partner.

- 4.12 As a continuing condition of entry each Participant shall ensure that, for the duration of the Event:
- 4.12.1 Safety approved cycle helmets are worn at all times when cycling;
  - 4.12.2 He/she is capable of carrying out basic bike maintenance, such as puncture repairs, whilst on the route;
  - 4.12.3 He/she does not start earlier than the official start time on each day of the Event. Failure to comply with this rule will result in being removed from the event;
  - 4.12.4 He/she completes each daily stage between the hours of the route operating window ("Route Operating Window") which is normally 7am to 7pm. In addition, he/she must start each stage within the start window of one hour ("Start Window"), normally 7am to 8am. Threshold reserves the right to alter the Route Operating Window and the Start Window each day in the event of mitigating circumstances;
  - 4.12.5 He/she cycles at a minimum average pace of 10mph, or above, each day. Pit stop cut off times will be advertised each day for this pace of rider. If a Participant falls behind this pace then he/she will be collected by the broom wagon and repatriated to the next base camp.
  - 4.12.6 He/she understands that pit stop cut off times are guides only. Threshold reserves the right to ask any rider to go on the broom wagon at any time, if they feel they are a risk to themselves, other riders, or are unnecessarily stretching the route support crew, even if they are still within the pit stop cut off times and/ or Route Operating Window.
  - 4.12.7 He/she understands the three-strike rule and will be asked to leave the Ride after the third strike and not permitted to take part in the remainder of the Event. He/she would get ONE strike if he/she:
    - 4.12.7.1 is collected during the day because they fail to make the pit stop cut off times;
    - 4.12.7.2 does not start on a particular day, and travels in the broom wagon to the next basecamp;
    - 4.12.7.3 does not start on a particular day, and organises their own transfer to the next basecamp but needs their bike to be transported by the broom wagon;
    - 4.12.7.4 does not start on a particular day and organises their own transfer to the next basecamp for themselves AND their bike. Riders must still tell Event Control if doing this;
    - 4.12.7.5 has left pit stop 2 within the cut off time but does not reach the finish before that cut off time;
  - 4.12.8 He/ she understands that Threshold shall have no liability whatsoever to any Participant who fails to complete the ride at an average pace of 10mph, but refuses to be collected by the broom wagon, and reserve the right to remove such Participant from the remainder of the Event;
  - 4.12.9 He/she understands that if they are removed from the Event for whichever circumstances outlined in these rules and regulations, no refund will be given by Threshold or any other party.
  - 4.12.10 His/her bicycle is roadworthy for the Event and equipped with the relevant insurances and documentation;

- 4.12.11 He/she does not use a mobile phone whilst cycling but has one on their person in case of emergencies;
- 4.12.12 Due to the outdoor nature and endurance aspect of the Event, he/she maintains personal hygiene at all times, and adheres to all hygiene advice provided by Threshold;
- 4.12.13 He/she does not use a music player with headphones whilst cycling;
- 4.12.14 He/she displays the official event numbers provided at registration in the manner indicated during the Event;
- 4.12.15 He/she does not deviate from the official signed route of the Event;
- 4.12.16 He/she abides by all Event rules and regulations;
- 4.12.17 He/she acknowledges that it is his/her responsibility to ensure that he/she has taken out a policy of insurance suitable for his/her participation in the Event.

Example of suitable insurance cover is outlined below, but not limited to:

- A minimum of £5 million public liability cover;
- Travel insurance that covers personal travel plans; and
- Insurance that covers personal belongings, including his/her bike

- 4.12.18 He/she complies with the Highway Code at all times; and
- 4.12.19 He/she obeys traffic officers and authorised marshals at all times; failure to do so will result in disqualification and removal from the Event.

## **5 PARTICIPANT WARRANTIES AND UNDERTAKINGS**

- 5.1 The Participant acknowledges that participation in the Event is not possible without validly entering into this agreement on these Rules and Regulations and agrees to be bound by these Rules and Regulations.
- 5.2 The Participant agrees at all times during the Event to abide by the reasonable instructions and guidelines of Threshold's staff, nominated representatives, and suppliers and to behave appropriately at all times on the route and in the base camps. Participants acknowledge and agree that Threshold will organise and run the Event and will have sole authority and be the final arbiter on all decisions relating to the following aspects of the Event: health and safety, logistical operations, participation, organisation and rules and regulations.
- 5.3 The Participant understands the endurance demands of the Event and commits to preparing to take part in the Event by:
  - 5.3.1 Complying with the Event monthly training plans (or comparable training advice);
  - 5.3.2 Consistently completing long distance rides (min. 80 miles) before the Event;
  - 5.3.3 Completing a number of training rides on consecutive days in order to experience fatigue brought on by persistent mileage; and
  - 5.3.4 Undertaking regular training within a group in busy road conditions (e.g. roundabouts, major junctions) in order to feel confident out on the road.
- 5.4 The Participant acknowledges that participation in the Event involves inherent risks of accidents and injury.
- 5.5 The Participant acknowledges that he/she is personally responsible for his/her own belongings during the Event, and that he/she must collect any personal lost items from lost property before he/she leaves the Event.

- 5.6 Participation in the Event is at the Participant's own risk. The Participant irrevocably agrees to hold harmless, indemnify and reimburse Threshold from and for any sum, costs or expenses (including legal and professional fees) incurred, payable or paid by Threshold to any person (including the Participant and/or any of the Participant's insurers) in connection with any accident, loss, damage or injury (including death) arising out of the Participant's attendance at and participation in the Event or any part thereof (except where any such injury or death is caused by the negligence of Threshold or any of its employees).
- 5.7 The Participant confirms without reservation that he/she is in a good physical condition to participate in the Event, that he/she understands the endurance demands of the Event, and will not arrive at the Event in ill health or unfit to take part.
- 5.8 The Participant confirms that he/she has suitable liability, personal accident and equipment insurance in place in order to participate in the Event and acknowledges that he/she has no claim against Threshold in relation to the provision of such insurance.

Threshold will have the right to remove any material at its discretion and take appropriate legal action against any person found to be or alleged to be in breach of this Clause 5.9.
- 5.10 The Participant's journeys to and from the start and finish lines of the Event shall be entirely at his/her own risk and cost.

### Event administration

- As the Event organiser, Threshold requires a record of your registration details including third party emergency contact details for internal administration purposes in order to properly conduct and to safely administer the Event.
- Threshold will also keep records of medical information provided that it is kept confidential and may be shared only with medical personnel or teams allocated to the Event. This data will be shared securely. #### **7 CHARITY PLACES & FUNDRAISING DECLARATION**

- 7.1 If taking part as a charity place, you are required to fundraise a minimum of £2,200 or the figure agreed by your charity.
